### 4. Tierra Rejada Well Rehabilitation Project, Specification No. PW 21-03

- 2) Authorized the General Manager to award a contract and issue a purchase order to General Pump Company (General Pump), in the amount of \$222,223.00, for the rehabilitation of the Tierra Rejada Well in accordance with Specifications No. PW21-03.

## 5. Lobby Redesign

- 2) Reimburse Apex General Contractors, Inc., for all governmental permits and fees related to the construction project, in an amount not to exceed \$2,500.00.

#### 6. Prepurchase GAC Equipment

The Board authorized the General Manager to:

- 1) Issue a purchase order in the amount of \$1,086,305.25 to AqueoUS Vets for the purchase of GAC vessels and extended warranty; and
- 2) Issue a purchase order in the amount of \$320,080.00 to Blue in Green (Chart Industries, Inc.) for the purchase of a CO2 dissolution system.
