**SUMMARY:** The Joint Powers Agreement indicates in article 13.2 that unless the Board of Directors

decides otherwise, the fiscal year for the Authority shall run concurrent with calendar year. For financial reporting purposes, the GSA is considered a blended component unit of the Camrosa Water District, and therefore, the financial statements of the GSA must be included within Camrosa's financial statements, and the fiscal year of both agencies must

run concurrently.

The State Controller's Office (SCO) requires that the GSA submits a Financial Transactions Report after the end of each fiscal year, which must tie to audited financial statements. After reviewing the report submitted for FY2020-21, the SCO noted that the Joint Powers Agreement indicated a Fiscal Year different from the Audited Financial Statements' Fiscal Year. The SCO has requested a resolution indicating that the Fiscal Year of the GSA coincides with the Fiscal Year of its Financial Statements.
