Subject: Drought Response

Objective: Discuss the latest mandate from Metropolitan Water District.

Action Required: No action necessary.

**Discussion:** At its May 26, 2022 meeting, the Camrosa Board of Directors adopted Resolution 22-03 declaring a State Two Water Supply Shortage. The declaration passed through the requirement by the District's wholesalers, Metropolitan Water District and Calleguas Municipal Water District, to limit outdoor watering with potable water to one day a week, with certain exceptions.

Requirements and expectations from the District's wholesalers continue to shift. Staff will present the latest requirements from Metropolitan for Board discussion.
