Subject: Virtual Town Hall

Objective: Present to and receive feedback from the Camrosa community.

Action Required: No action necessary.

Discussion: At its May 26, 2022 meeting, the Camrosa Board of Directors adopted Resolution 22-03 declaring a State Two Water Supply Shortage. The declaration passed through the requirement by the District's wholesalers, Metropolitan Water District and Calleguas Municipal Water District, to limit outdoor watering with potable water to one day a week, with certain exceptions.

The District will host a virtual town hall meeting to impart to its customers the reasons for the Water Supply Shortage, what the District's approach to conservation this summer will be, and what our plans for the future are.
