DISCUSSION: The Arroyo Santa Rosa Groundwater Sustainability Agency (ASRGSA) is currently funded

through contributions from the two agencies party to the joint powers authority: Camrosa Water District and the County of Ventura. As stated in the attached letter, the County believed their total financial commitment to the GSA was \$100,000, while Camrosa staff believed that their commitment was a yearly contribution capped at \$100,000 per year. The County had an outstanding invoice of \$66,794.44, which would increase their total funding to \$127,602.45. In discussions with County staff, they agreed to pay the full amount of the outstanding invoice, but will provide no further funding. As such, the cost to finish the GSP and continue operating the GSA as of now falls to Camrosa. Camrosa's FY22-23 budget, approved at the June 23, 2022 meeting of the Camrosa Board of Directors, has sufficient funds to cover the GSA for the upcoming fiscal year. This memo is intended to provide some context for a Board discussion about

Should the Board determine an alternative to Camrosa's continued funding of the ASRGSA, staff recommends that the Board create an ad hoc committee to develop the funding structure and adopt it as an ordinance at a future meeting. Two primary sources of funding present themselves: the pumpers of groundwater and the users.

In many cases across California, GSA costs are borne by the producers of groundwater. Administrative functions are funded by extraction fees, which can be levied ahead of and concurrent with the development of the GSP, and project and management action costs are funded through replenishment fees, which must be developed after and as a result of the GSP.

Alternatively, the users of groundwater can fund the GSA, through existing or new rate structures or assessments. Sustainability projects and management actions are then funded by project proponents and beneficiaries.

Some combination of the foregoing is also possible.

From initial investigations, pumping in the Santa Rosa Basin appears relatively sustainable. Land use is well established, with much of the overlying land in the Santa Rosa Valley governed by S.O.A.R., the Ventura County initiative that only allows changes to zoning designations in certain areas by a vote of the public. Camrosa is the single largest producer in the basin, delivering Santa Rosa Basin groundwater to most of the overlying parcels, including significant agricultural acreage, as well as to its customers beyond the confines of the basin. The District plans to pursue its strategy of "building self-reliance," and is looking to the Santa Rosa Basin as a key resource in their expansion of local groundwater production. Expansion of groundwater production in the Santa Rosa Basin appears as of today principally benefit Camrosa customers. The additional modeling contemplated by phase two of the INTERA proposal, which would allow the GSA to do complex modeling necessary to run a variety of planning scenarios, including projects to recharge the basin, increase pumping, and otherwise increase sustainable yield, requires the installation of meters on all production wells.

The argument to fund the administrative costs of the GSA through extraction fees levied on private pumpers as well as Camrosa also rests on the metering of wells. Crop types change over time, and should growers on parcels fed by private wells move to more water-intense crops, their groundwater production would also increase, representing a stake in an increased sustainable yield. The only way to track groundwater production is through the installation and monitoring of production meters. The Sustainable Groundwater Management Act endows GSAs with the power to levy extraction fees to pay for the administrative costs of monitoring extraction through metering. If private pumpers express (or ultimately demonstrate) a stake in increasing sustainable yield, they would contribute to projects and management actions through a replenishment fee.

During our meeting on May 11, 2022, we discussed the different viewpoints on the County's total financial commitment to the ASRBGSA. While I believe that from the beginning, the County's commitment was \$100,000 in total, you contend it was \$100,000 annually.

We currently are in receipt of invoice #13 dated April 14, 2022, for \$66,794.44. Payment of this invoice will bring the total funding from the County to \$127,602.45. Although this amount exceeds what I believe is the County's commitment, after considering your points from our meeting, the County will pay the full invoice amount.

However, from now on, the County will provide no additional financial contribution to the ASRBGSA. The beneficiaries of the water resource should fund the GSA. I request you bring this matter as an agenda item with your Board.

DISCUSSION: The groundwater sustainability plan (GSP) is well underway, with submission to DWR

anticipated in April 2023. Approximately fifty percent of the budget has been expended to date. The remainder comprises the majority of the budget for FY22-23. Other costs

include stakeholder outreach and miscellaneous fees and charges.

The joint powers authority governing the Arroyo Santa Rosa Groundwater Sustainability contemplates funding the GSP through a cost-sharing arrangement between its two members, the Camrosa Water District and the County of Ventura. Contributions from the County will not continue after FY2021-22, so the FY22-23 budget, including the remainder of the GSP and administrative functions of the GSA, will be funded via contributions from Camrosa Water District. Camrosa has budgeted for this in its FY22-23 operating budget, approved by its Board of Directors on June 23, 2022.

Overview

This memorandum serves as a cover message for the Arroyo Santa Rosa Groundwater Sustainability Agency's (ASRGSA) Fiscal Year (FY) 2022-23 budget. It describes the governance and purpose of the ASRGSA, the plan for the annual budget, and the basis of accounting.

Agency Governance

The ASRGSA is organized under a joint powers of authority agreement (JPA) between the Camrosa Water District and the County of Ventura. Camrosa is the water purveyor for the Santa Rosa Valley and the largest producer of groundwater from the Santa Rosa Basin; the County retains land-use jurisdiction over the unincorporated valley. The six-member Board of Directors holds meetings as necessary, though it intends to establish a regular schedule this fiscal year. Meetings are publicly noticed.

The GSA is staffed by an Executive Director, treasurer, controller, and auditor, appointed by the Board. The GSA Board appointed Tony Stafford, the GM of the Camrosa Water District, as Executive Director, and determined that the auditor of the Camrosa Water District's finances should also audit the ASRGSA. According to the JPA, the treasurer and controller positions shall be filled by Camrosa Water District staff. Currently Tamara Sexton, Camrosa Manager of Finance, acts as treasurer, and Sandra Llamas, Camroa Senior Accountant, as controller. Other duties and activities necessary to accomplish the ASRGSA's business are carried out by Camrosa Water District employees.

Agency Purpose

The purpose of the ASRGSA is, as defined by the Sustainable Groundwater Management Act (SGMA), the agency's enabling legislation, to achieve sustainability within the Santa Rosa Basin by 2042. The vehicle for achieving this, and the primary focus of the agency this fiscal year, is the groundwater sustainability plan, or GSP.

The GSP is a management plan document that evaluates sustainability as it relates to six indicators of basin health: groundwater levels, groundwater storage, seawater intrusion, water quality, land subsidence, and groundwater-surface water interconnection. The GSP will set minimum thresholds for each of the applicable criteria and develop associated management actions to avoid undesirable results and achieve sustainability.

FY22-23 Budget Development

The GSP was begun in FY21-22. INTERA, a geotechnical consulting firm, was hired to do the technical work of the GSP and Bryan Bondy, of Bondy Groundwater, Inc., was engaged to act as a consulting project manager, overseeing INTERA's work, organizing public outreach, and contributing to chapters of the GSP. As demonstrated in the attached budget, GSP work constitutes the bulk of the FY22-23 budget. The plan is expected to be complete by April 2023.

The ASRGSA has to this point been funded through matched contributions from Camrosa Water District and the County of Ventura. Contributions from the County will not continue in FY22-23 and beyond; as such, the cost to finish the GSP and continue operating the GSA as of now falls to Camrosa. Camrosa's FY22-23 budget, approved at the June 23, 2022 meeting of the Camrosa Board of Directors, has sufficient funds to cover the GSA for the upcoming fiscal year. What long-term funding of the GSA will constitute—extraction fees, replenishment fees, or the continuation of Camrosa support—is expected to be taken up by the GSA as a policy matter in FY22-23.

The ASRGSA received a Proposition 1 Sustainable Groundwater Planning Grant of \$177,081, which is currently being invoiced against. The grant agreement with the California Department of Water Resources, updated in April 2022, provides until June 30, 2023 for submittal of the final GSP.

Other expenditures include legal support, insurance, public outreach support, and necessary general materials and supplies.

Discussion:

Your Board, on November 16, 2021, appointed Directors, and where needed Alternate Directors, to the GSAs on which Ventura County has a seat on the Board. The item passed, but the motion did not name who would be appointed to each GSA Board. The action was later clarified and entered in the minutes as follows: "Approve reappointing same Directors and Alternate Directors to the Boards of the Groundwater Sustainability Agencies." This is different from staff's recommendation which provided, "If not filled by a Supervisor, appoint the Public Works Director or their representative."

This item is returning to your Board to take action consistent with staff's original recommendation for appointments not filled by a Supervisor. Your Board reappointed Supervisor Long to the Fillmore and Piru Basins GSA, and no further action is needed with that appointment. For the other Boards, it is recommended that your Board rescind the re-appointment of the same Directors and Alternate Directors of Arroyo Santa Rosa Basin, Cuyama Basin, Mound Basin, and the Upper Ventura River GSA Boards.
