# **Board Memorandum**

Subject: Drought Update

**Objective:** Provide the public with an update on the drought and receive feedback from the community.

Action Required: No action necessary.

**Discussion:** On April 26, 2022, Metropolitan Water District (MWD) adopted a resolution declaring a water shortage emergency condition and implementing an Emergency Water Shortage Conservation Program in the State Water Project-dependent areas of its service area in accordance with California Water Code Section 350. This includes the Callgeguas Municipal Water District (CMWD) service area. On April 27, CMWD also declared a Section 350 Water Shortage Emergency Condition for its service area, which includes Camrosa.

The CMWD Emergency Water Shortage Conservation Program provides two paths for purveyors to reduce the use of State Water Project water: restrict "non-essential" outdoor irrigation to one day a week or comply with monthly allocation limits. Non-compliance with the either of the two paths could result in a \$2,000/AF fine from Metropolitan.

On June 23, 2022, the Camrosa Board of Directors declared a Stage Three Water Supply Shortage, modifying the standard regulation in Camrosa's Ordinance 40 to pass through the one-day-a-week outdoor watering limitation from our suppliers. Since then, Camrosa has remained in compliance with the Metropolitan/Calleguas requirements.

During this town hall event, Camrosa staff and Board will brief the public on the state of the drought and the current status of regulations regarding water-use restrictions as we head into 2023.
