Objective: Ratify the actions taken during a fire hydrant repair and relocation on Fieldcrest Drive.

Action Required: Ratify purchase orders totaling \$26,679.63 to J&H Engineering, Inc. for a fire hydrant repair and relocation on Fieldcrest Drive.

Discussion: Fieldcrest Drive had a fire hydrant that was obstructed by a tree, was fully encased by its roots, and was leaking. We needed to repair the leak and relocate the hydrant away from the tree and its roots. We met with the city inspector before the job to go over logistics and agreed on a new location for the hydrant. The project went out to bid, and the job was awarded to J&H Engineering, Inc. for \$21,700.00.

Once the job started, the city inspector informed us that the hydrant would need to be relocated to a different spot according to his superiors. After many calls back and forth with the city inspector, we agreed on a new location. This second relocation required additional work, including the removal and replacement of sidewalk panels and the purchasing of additional parts.

J&H completed this additional work on a time-and-materials basis for \$4,979.63, bringing the total project cost to \$26,679.63.

Action Required: No action is necessary; for information only.

Discussion: Receive a report on the district's water quality results and compliance posture for the 4th quarter of 2024.

Potable Distribution System

- 4 Positive Total Coliform Results this quarter
 - Positive results occurred in November in the weeks following the Mountain Fire triggering a level 1 assessment of our distribution system. All resamples were negative. Results from the assessment concluded that the Total Coliform Positive detections were most likely due to windy weather conditions on the days of sampling and environmental quality following the Mountain Fire.
 - During the assessment, changes were also made to our Bacti Sample Siting Plan to provide more accessible areas for sampling as well as adjust some upstream and downstream sampling points that were modified due to changes in the system flows in some areas.
 - The Department of Drinking Water (DDW) accepted the Level 1 assessment as well as the changes to our Sample Siting Plan.
- Reservoir Chlorine Levels were checked weekly and boosted as necessary.

Potable Water Quality Treatment

- GAC Plant is in full compliance with all regulatory requirements.
- Round Mountain is in full compliance with all regulatory requirements.
 - Round Mountain was offline in November and December due to the University Well being down.

All systems are expected to go live in April 2025. All in-house ACH customers will be notified shortly of the transition to InvoiceCloud.

<u>Cross-Connection (Backflow)</u>: monitoring by the County is scheduled to end on June 30, 2025. Staff are working on selecting a vendor to provide the services required by the State Cross-Connection Control Protection Handbook. Backflow non-compliance remains low at 1.5% of the 1,472 backflow devices in the system.

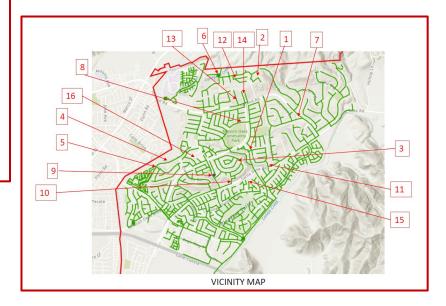

Subject: Santa Rosa Well No. 10 Rehabilitation

Objective: Award contracts for Phase 1 rehabilitation services for the Santa Rosa No. 10 Non-Potable Well.

Action Required: It is recommended that the Camrosa Board of Directors:

- Authorize the General Manager to issue a purchase order to General Pump Company in the amount of \$45,087.00 for Phase 1 rehabilitation services for the Santa Rosa Well No. 10 Non-Potable Well; and
- *2)* Issue a purchase order to Hopkins Groundwater Consultants in the amount of \$64,760.00 to provide professional evaluation and rehabilitation services.

Discussion: As a result of declining water levels, production loss, and operational issues, the Santa Rosa No. 10 Well is in need of rehabilitation. In addition, as part of Phase 1 of the District's Master Plan, this well has the potential to be converted to a potable supply well for the proposed Conejo Desalter project and will require some piping modifications and replacement of the MCC and controls.

Santa Rosa Well No. 10 (SR 10) is a non-potable water well located on the north side of Santa Rosa Road between Hill Canyon Road and Yucca Drive, about 525 ft away from the Conejo Wellfield. The well was originally drilled in 1954 and operated by Santa Rosa Mutual as a potable water well and was eventually acquired by the District. Its current condition is considered a sub-standard facility. The well needs to be refurbished to improve production and efficiency. Also, the building that houses the well is old and needs to be replaced to improve the overall workspace area, ventilation, lighting, and sound attenuation. This well has been identified in the District's Master Plan to be converted to a potable production well for the proposed Conejo Desalter project.

Since acquiring the well from Santa Rosa Mutual, this well has not been cleaned or rehabilitated. Production has slowly degraded over time. Although the specific reasons for the loss of production is not fully known, it is assumed that it is most likely the result of plugging of the formation and well screen, along with declining water levels.

SR 10 utilizes an oil lubrication system, which over time causes build-up of oil on the water surface. This can be problematic as it limits the operator's ability to increase pumping drawdown. To improve production and efficiency, staff would like to evaluate the well's condition and convert the existing oil lubrication system to a freshwater flush system. In addition, the well is not equipped with automatic level transducers and that will be installed as part of the rehabilitation project.

This project includes the evaluation of the existing well, pump and motor. It is expected that the well will be redeveloped, and installation of a new pump assembly will be required along with a freshwater lube system. Also, the existing building will be demolished and replaced with a new prefabricated structure.

This project involves two phases:

- Phase 1: Pulling the well and evaluation.
- Phase 2: Cleaning, rehabilitation, equipment specifications, electrical, controls, piping and valve replacement/modifications.

The well will be pulled and videoed to evaluate the existing condition of the well casing and screens along with the pump assembly and column pipe. Depending on the condition of the pump equipment and well, a redevelopment plan and specifications will be prepared and executed. Upon the condition of the pump bowls and assembly, it will either be cleaned or replaced. Staff is expected to obtain proposals for engineering services that will perform electrical switchgear and MCC replacement design along with piping modifications and a new prefabricated building.

The District has solicited a proposal from Hopkins Groundwater Consultants for Phase 1 to assist in preparing a rehabilitation scope, and construction inspection and monitoring services. The proposed work includes:

- Well Condition Assessment
- Well Rehabilitation Specifications
- Well Rehabilitation Observation & Documentation
- Summary of Operations Report
- Project Management & Meetings

Hopkins is under an annual services agreement with the District and has performed various other hydrogeological services for the District. Hopkins is familiar with the construction and development of the SR 10 and their fee proposal in the amount of \$64,760.00 for the above specified work is fair and their proposed timeline of approximately 2 months to complete this project is reasonable.

As part of Phase 1 evaluation, staff solicited a proposal from General Pump Company (GPC) to pull the well along with a light brushing and airlifting, if needed. Subsequently, they will perform a well video that will provide useful information that will assist Hopkins in developing an overall condition assessment and rehabilitation plan. This work will be done under the District's general services agreement with GPC. GPC's proposal of \$45,087.00 was determined to be fair and reasonable.

Once the rehabilitation specifications are complete and rehabilitation costs are known, staff will move forward with Phase 2, which consists of the actual well-rehabilitated, modified pump reinstallation and engineering services. Once the Phase 2 costs are known, staff will return to the Board and request additional funds for this portion of the work.

This project is budgeted for in FY FY24-25 from the District's Non-Potable Water Capital Improvements Fund in the amount of \$215,000.00.

Subject: Pond Pump #4 Replacement CIP

Objective: Establish a Capital Improvement Project (CIP) for Pond Pump #4 replacement.

Action Required: It is recommended that the Camrosa Board of Directors:

- 1) Appropriate \$100,000.00 from the Non-Potable Capital Replacement Fund and establish a Pond Pump #4 Replacement Capital Improvement Project (CIP); and
- 2) Authorize the General Manager to issue a purchase order in the amount of \$78,157.90 to General Pump Company, Inc. for the repair of Pond Pump #4.

Discussion: Pond Pump #4 is a critical part of the delivery of water into our non-potable surface water system. Pump #4's motor failed, the packing had excessive leakage, and the pump needed a rebuild. General Pump was available to pull both the motor and the pump for transport back to their shop for teardown and inspection. After evaluation with General Pump, staff plans to rebuild the pump and reuse the existing pump head. This purchase order includes the removal, repairs, reinstallation of the pump and motor, and startup.

The 350-hp motor was repaired by Walton Motors, Inc. for \$14,484.05 and is at General Pump's shop, ready for installation.

Staff recommends establishing a CIP to capture the expenditures for this project.

Subject: University Well Pump Replacement Project

Objective: Establish a Capital Improvement Project (CIP) for replacement of the University Well pump.

Action Required: It is recommended that the Camrosa Board of Directors:

- 1) Appropriate \$200,000.00 from the Potable Capital Replacement Fund and establish a University Well Pump Replacement Capital Improvement Project (CIP); and
- 2) Authorize the General Manager to issue a purchase order in the amount of \$109,035.35 to General Pump Company, Inc. for the repair of University Well.

Discussion: University Well is the sole source of water for our Round Mountain Water Treatment Plant (RMWTP), a big contributor to our local potable water production. The VFD for this well failed on November 1st. Staff investigated, and they ordered and replaced the VFD. However, attempts to restart the well were unsuccessful. The well was unable to maintain sufficient freshwater lube flow and the pressure required to operate. Staff worked with General Pump to investigate this issue, however the pump needed to be pulled in order to inspect the downhole components.

Upon pump teardown and inspection, the lube line weep holes were found to be plugged with what appeared to be a buildup of iron-reducing bacteria. The pump bowls have a significant amount of corrosion damage. This damage is beyond repair, and the pump needs to be replaced. The pump bowls made of cast/ductile iron are the last component of the well that is not stainless steel. Over the life of this well, corroded components have been replaced with stainless steel, giving good results. This pump is the last weak link that is not stainless steel and should be upgraded.

Staff recommends establishing a CIP to capture the expenditures for this project. This project also includes the cost of the VFD replacement (\$32,190.36) and pulling the pump (\$31,560.00).

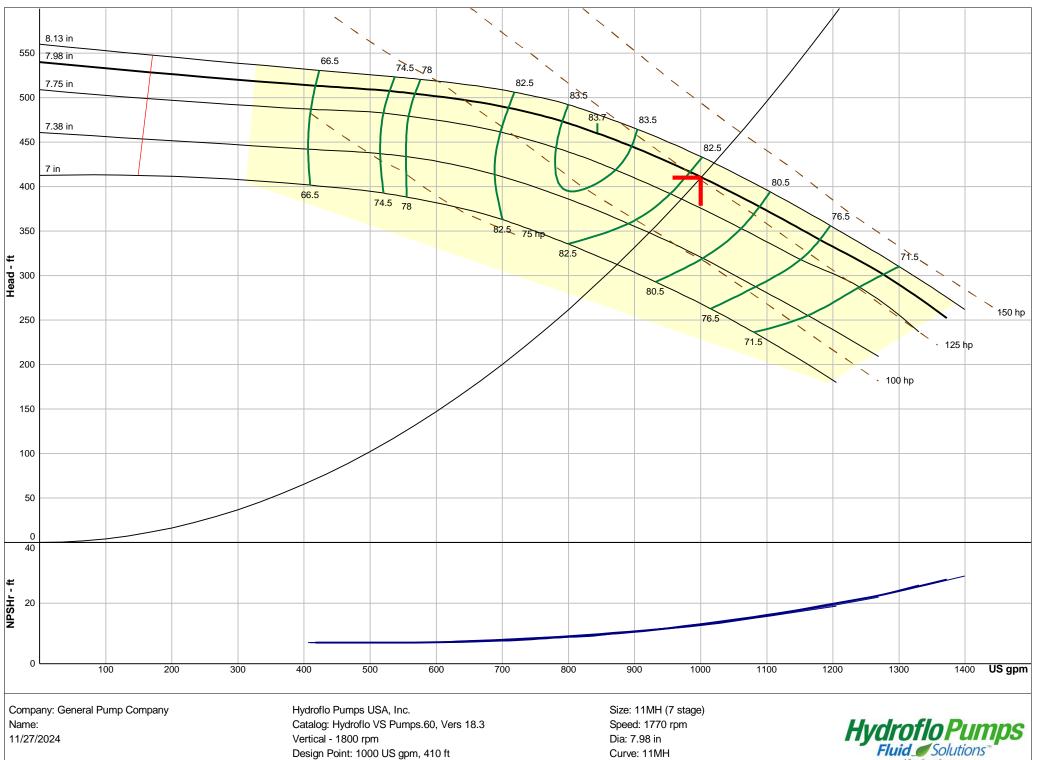

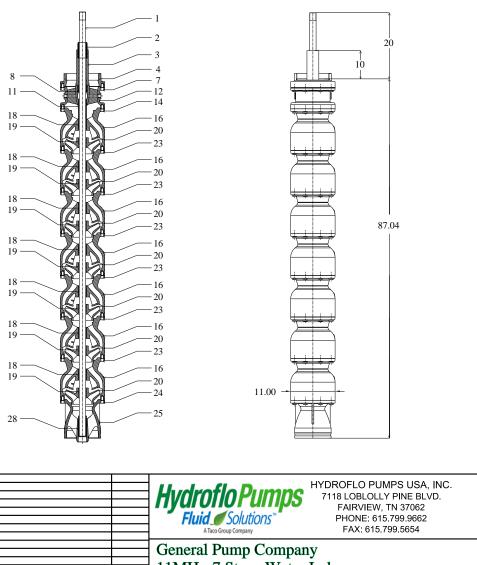

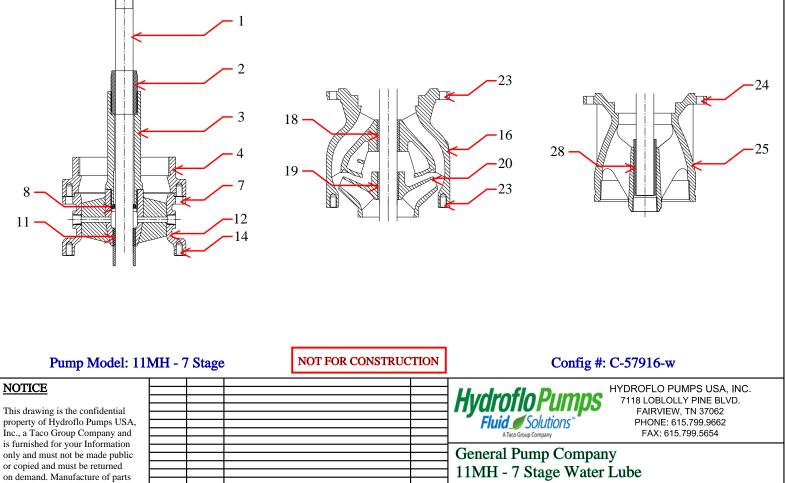

Subject: Fleet Vehicles Lease

Objective: Enter into a 60-month fleet lease agreement.

Action Required: Authorize the General Manager to enter into a 60-month fleet lease agreement with Enterprise Fleet for six new F-250 Super Duty trucks with a total lease cost of \$7,129.14 per month.

Discussion: Camrosa operates a fleet of 23 vehicles, 16 of which are currently leased through Enterprise Fleet. The new leased vehicles will consist of end-of-term replacements for six F-250s. These vehicles are assigned to our Control Systems Supervisor, Instrumentation Technician, Wastewater Operator, Distribution Operator (Customer Service & Meters), and two Treatment Operators.

Camrosa began leasing fleet vehicles in 1997. Leasing vehicles for a 60-month term allows the District to maintain a safe and reliable fleet while minimizing maintenance and repair costs.

The proposed 60-month lease agreement for the six new F-250 Super Duty trucks is \$7,129.14 per month. All vehicles will come with the necessary safety and utility equipment pre-installed. This includes a utility toolbox with ladder rack, LED work lights, traffic control light bar, and front, side, and rear strobe lights.

Our current lease term ends Nov-Dec 2025. The factory window is open now to order vehicles, and with the current delivery times, they should arrive Nov-Dec 2025.

This is a monthly expensed line item in the Fiscal Year budget that will begin in FY25-26 when the new leased vehicles replace the current F-250s.

Subject: Non-Potable and Recycled Water Resources Allocation Policy

Objective: Discuss maximizing the beneficial use of the District's non-potable and recycled water resources.

Action Required: For discussion only; no action is necessary.

Discussion: The District's Strategic Plan outlines 5 Strategic Vision Goals. Goal #1 is Water Supply Independence. Potential strategies within this goal, related to maximizing the beneficial use of the District's non-potable and recycled water resources, are:

- a. Maximize beneficial use of Camrosa's wastewater.
- b. Preserve existing non-potable water resources to increase the reliability of the District's potable water supply.
- c. Offset potable water demands by extending the non-potable distribution system into areas where it is not currently available and maximize the beneficial use of available non-potable supplies through groundwater recharge and treatment.

Currently available non-potable and recycled water resources include:

- Non-potable surface water from the Conejo Creek Project (CCP) ≈ 8,000 AFY
- Non-potable groundwater from Camrosa's Santa Rosa NP Wells ≈ 600 AFY
- Recycled water from the Camrosa Water Reclamation Facility (CWRF) ≈ 1,350 AFY
- Recycled water from the Camarillo Sanitation District (CamSan) ≈ 1,350 AFY

Potentially available non-potable and/or recycled water resources could include:

• Recycled water from Simi Valley's Water Quality Control Plant (SWQCP) ≈ 11,200 AFY

Opportunities to maximize the beneficial use of the District's non-potable and recycled water resources can be implemented through a phased approach.

Phase 1 – NP System Conversion to Recycled

Elements:

- a. Convert the current Camrosa NP water distribution system to a Recycled water distribution system.
- b. Serve CWRF and CamSan Recycled water to current Camrosa NP customers rather than to PVCWD. ≈ 2,700 AFY

c. Serve the NP CCP water currently being served to Camrosa NP customers to PVCWD to accrue PVB extraction credits. \approx 2,400 AFY

Phase 2 – NP Well Conversion to Potable

Elements:

- a. Convert the current Camrosa NP wells to Potable and treat the water through the Conejo RO facilities or take the current Camrosa NP wells offline and use the current Conejo potable wells to pump this available SR basin supply. ≈ 500 AFY
- b. Should the Camrosa NP demand remain constant, this demand would have to be met with either increased recycled supplies or with CCP non-potable supplies (which would reduce the accrual of PVB extraction credits).

Phase 3 – Recycled System Expansion, Upland Rd.

Elements:

- a. Expand the Recycled water distribution system to serve the (dual-plumbed communities of The Grove, Calarosa, and Pinnacles) reducing the demand on the potable system.
 ≈ 220 AFY
- b. Colocation of the expansion pipeline with the Calleguas SMP alignment could provide significant CIP cost savings.
- c. Other potential expansions in this area include several park sites.

Phase 4 – Recycled System Expansion, Andalusia Rd. & Vista Aroyo

Elements:

a. Expand the Recycled water distribution system to serve additional customers in the Santa Rosa Valley reducing the demand on the potable system. ≈ 460 AFY

Phase 5 – Simi Recycled Water

Elements:

- a. Contract with and connect to Simi Water Quality Control Plant (WQCP) for recycled water delivery.
- b. Connect Simi to the Camrosa recycled system on Santa Rosa Rd. (potential alignment route through Tierra Rejada Rd, Sunset Valley Rd., and Read Rd. ≈ 7.3 miles)
- c. Serve Simi recycled water to ag users in the Eastern Santa Rosa Valley, Tierra Rejada Valley, and Moorpark along the new alignment route. Deliveries of recycled water to new customers could reduce basin pumping and allow for more potable extractions by Camrosa in these basins.
- d. Fill the remaining demand of Camrosa recycled water customers, allowing 100% of the CCP resources to be served to PVCWD, maximizing the accrual of PVB extraction credits.

Phase 6 – Basin Recharge

Elements:

- a. Use surplus Simi, CWRF, and CamSan recycled water for TRB and/or SRB recharge with Camrosa TRB and/or SRB spreading basins, conveyed through the Camrosa recycled water distribution system.
- b. Could increase Conejo Wellfield capacity with Conejo GAC/RO treatment, and CMWD wheeling back to Simi/TO.
- c. An expanded Camrosa recycled water distribution system could convey Simi recycled water to the PVB and OxB via deliveries to PVCWD.

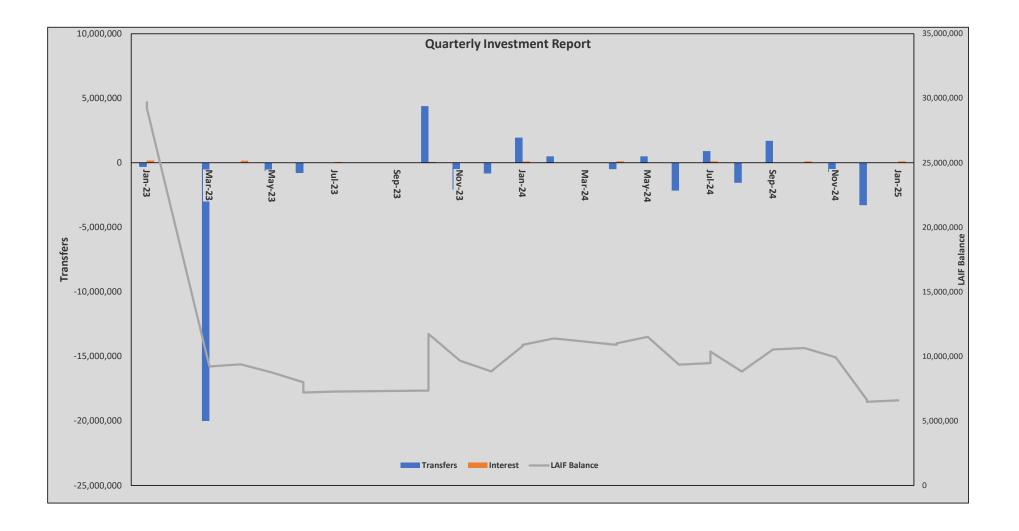
